Reason:

The proposed expansion of this house located within the Green Belt entails a significant percentage increase in floor area relative to the original dwelling. However, we still believe there are grounds in favour of approving this application including the relatively small scale of the original dwelling when making comparisons and the fact the enlarged dwelling will remain of a scale and character in keeping with this private road. The potential harm to the openness of the Green Belt arising from this development also appears to be very limited.

5.4 Outdoor terraced dining area and two food cabins

The latest submitted plans for this restaurant show the creation of a permanent structure to the frontage of the premises which will enclose an area currently used for outdoor dining. Whilst we have no objection to the continuation of an outdoor eating area in this position, we believe the proposed permanent all-weather structure will represent excessive development of the site in a position where it will appear highly unsightly when seen from the nearby well-used public areas. Moreover, the simple wooden walls and Perspex roofing being proposed will contrast oddly with other long-established structures nearby including the main Meridiana restaurant building itself.

The Meridiana restaurant is located in a very prominent position within the East Horsley District Centre and such a stark structure so close to this busy public area is likely to appear unsightly and so would have a very detrimental impact on the local street-scene. As such this development will be contrary to Local Plan Policies D1(4) on Place Shaping and Policy D4 on Achieving High Quality Design and Respecting Local Distinctiveness.
