Chairman's Comments

Strains on our local road network

OUR LOCAL ROAD system has been under severe pressure this year. In mid-January there was a week when the coincidence of local flooding, major road works, a collapsed sewer and a gas leak made it impossible to travel northwards from the Horsleys without making an enormous diversion. Thankfully, our local shops were still able to provide key services and products within the confines of the village.

Surrey Highways choose this period to consult on its plans to reduce the speed limit for Chalk Lane to 30mph. EHPC, supported by local residents, submitted a detailed letter arguing that the speed limit should be 20 mph – See EHPC website for more details.

A busy spring in prospect

On **25 April** our **Annual Parish Meeting** will be held when residents can question parish councillors about what they've been doing this past year and make suggestions for the year ahead.

The meeting starts at 7.30pm in the East Horsley Village Hall. The second half will be an open session when residents can talk directly with your parish councillors over a coffee or glass of wine.

On **4 May** the **Local Elections** for both our borough and parish councils are being held. Please note you will need a photo ID to be able to cast your vote in person. If any residents are considering standing for either, please contact our Parish Clerk to learn more about what is involved and the process that needs to be followed to become a councillor.

On **6 May** the **Coronation of King Charles** is taking place and we aim to have the village fitted out with suitable decorations for the occasion. For more details see page 9.

Update From Your Local Councillors

It's been a busy few months for your councillors at both Guildford Borough Council and Surrey County Council.

AT BOROUGH LEVEL the good news is that we have helped ensure Guildford Borough Council (GBC) reviews the dreadful Local Plan with a view to (hopefully) returning green field sites to the Green Belt and reducing the housing numbers (see page 3).

At local level we have been seeking to broker a deal which will enable the currently unused Bowling Club green to become a community garden at St Martin's Court, and hopefully we will have more on that very soon.

Since becoming councillors for Clandon and Horsley nearly four years ago we have worked to help make the full HART (Horsley Accessible Ring Trail around the village) become a reality.

This is something which everyone recognises will benefit our community and has been campaigned for by the Parish Council and residents for some time, however it has been far from plain sailing.

Thanks to the persistence of Catherine Young (GBC Councillor) together with East Horsley Parish Council (EHPC) it looks as though we are now finally close to getting the necessary permissions to achieve full accessibility to the trail – fingers crossed!

Meanwhile highway issues continue to plague the Horsleys with Surrey County Council (SCC) continually being chased on road repairs and flooding, and being pressed to resolve a series of apparently uncoordinated road closures, causing chaos in and around our villages.

More works are planned and Catherine Young

is at the front of our attempts to get these scheduled sensibly in future. She is also meeting National Highways in the next few weeks along with local Parish Council members to facilitate regular updates for our villages on the M25/Jct10 scheme, as there has been little community briefing on this so far.

Following the success of the joint campaign by all of us working with officers and residents to curtail the industrial concrete crushing activities at Brick Kiln, we are staying in close liaison with Enforcement Officers at GBC and SCC now that the site has, in theory, been shut down.

There has been some further activity noted by local residents and reported to the correct authorities. Many thanks to Chris Campbell and his team as they keep a watchful eye on the site.

We are all also involved in continuing to work on behalf of residents who are desperately awaiting determination of their planning applications.

Despite the injection of nearly £1million into its Planning Department, GBC lags at the bottom of the league table of councils in speed of decision-making and it remains a constant source of frustration for us in trying to get your voices heard.

In recent weeks there has been some improvement, and the Government's threat of putting GBC Planning into special measures will no doubt help concentrate minds in the department.

Becoming a Parish Councillor

With 55 properties moving from Effingham Parish Council into East Horsley PC, the number of EHPC members is expanding from 9 to 12. In addition elections for Guildford Borough Council take place on 4 May. Here Parish Councillor Steve Harvey and GBC Councillor Catherine Young encourage you to step up and help make a difference.

MENTION THE WORDS "Parish Council" and quickly you note eyes glazing over as you discuss the latest council initiative. Yes, being a parish councillor can occasionally involve dealing with bureaucracy, however it also provides an opportunity to make a difference in East Horsley.

For example, in recent years your Parish Council has launched this newsletter and a website, built a skate park and a multi-use games area on Kingston Meadow with new toilet facilities nearby. We've lobbied for upgrades to the approach road and car park at Horsley Station and for better platform facilities, installed attractive planters around the village, managed woodland paths, arranged to fly flags above shops on special occasions, organised decorations at Christmas time and staged well attended community events at Horsley Towers.

This is in addition to scrutinising scores of local planning applications each year and making grants available to local groups and charities. There are lots of new initiatives in the pipeline including a campaign to provide wheelchair access to station platforms and the upgrading of shopping facilities in the village. It's an exciting time and we'd love you to join us on this journey. Contact Nick Clemens at parishcouncil@easthorsley.org for more information.

The Local Elections take place this year on 4 May and this is a great opportunity to represent your community at Guildford Borough Council (GBC). In 2019 I was elected as the Guildford Green belt Group (GGG) GBC Councillor for the ward of Clandon & Horsley, following in the footsteps of David Reeve (GGG, 2015 – 2019). I campaigned in partnership with Tim Anderson and Christopher Barrass, Residents for Guildford and Villages (R4GV), also elected in 2019. The main thrust of our campaign was to try and stop the Local Plan's effects on the Horsleys. Sadly, once this

was adopted by the Conservative administration in April 2019, just before the election, there was little we could do, except pick up the challenge of fighting against every inappropriate development identified for East and West Horsley.

Planning has continued to dominate my work as a Councillor. I've worked with many residents chasing their applications, getting Tree Preservation Orders on vulnerable trees, and pressing for enforcements where planning breaches are occurring (such as at Brick Kiln and Newmarsh Farms). At times this is frustratingly slow, but being persistent has its rewards.

I've worked with the local community during the pandemic to set up contact groups of residents and services, volunteered to deliver shopping and also brought GBC in to help with the Home Office takeover of Thatcher's Hotel. There is also the opportunity to sit on working groups and committees so you get to find out about how the council works. I'm currently on the Joint Executive Advisory Board, reviewing projects and advising the Executive. I have just finished working on the GBC Climate Change Action Plan which is due to be adopted shortly, and I was on the Local Plan Panel to evolve the new Development Management Policies that seek to protect our borough from some of the effects of the Local Plan.

So, for anyone tempted to stand for election in May, my advice is to make sure you get involved with the local community, follow up issues that are of concern to residents who are our priority and also take the chance to engage in other processes designed to help shape Guildford.

And in the words of the late Jen Powell, Honorary Freeman, Guildford Borough Council, remember it's "Our Council" not "The Council".

LOCAL PLAN UPDATE

Our local GBC councillors report on moves to have the 2019 Local Plan reviewed and revised.

GUILDFORD GREEN BELT GROUP (GGG) and Residents For Guildford and Villages (R4GV) councillors have successfully managed to pass a motion at full council which commits GBC to investigate if it is now possible to return allocated green field sites to the Green Belt and also reduce the number of houses imposed by central government on the council to build.

The motion was opposed by Conservative councillors, but supported by the majority of the rest of the council.

The motion passed reads:

Guildford Borough Council is legally obliged to review the Local Plan 2019 by April 2024.

Having taken Counsel's advice, the Council previously debated and decided not to accelerate this review because of the risk of higher housing targets being imposed. This could have brought more pressure and threat

to the Green Belt, not less, and therefore would have been counterproductive.

Nevertheless, the Council also decided to put in hand some preparatory work to enable that 2024 review of the Local Plan.

Since that decision was taken, there have been speeches by the government that suggest they are more protective of the Green Belt. There is considerable uncertainty in the planning system: changes to the National Policy Framework (NPPF) are being consulted on; there are proposed changes to the Standard Method (used to calculate the number of homes required); and there may be changes to the legislation as part of the Planning Reform Bill.

All this is new compared to when Council last debated whether to conduct an early review or update of our Local Plan.

The Council therefore RESOLVES:

- That as part of a Local Plan update 2024, Council will investigate:
 - whether there are exceptional circumstances that would enable the return of allocated, but as yet undeveloped, countryside sites to Green Belt status and how to effect this; and
 - the possibility of reducing the local housing need figure according to the Standard Method, as well as the housing allocation number for each allocated site not yet brought forward, in light of Guildford's specific issues relating to high student numbers and significant environmental constraints.
- That consideration should then be given to whether this potentially reduced local housing need figure can be delivered sustainably in light of the increased priority of environmental factors.

The third quarter of the financial year is now complete and the year-end accounts are fast approaching. Income and expenditure has been as expected. The budget for 2023-24 has been agreed and the precept request has been made to GBC. Your Council has kept the band D equivalent council tax at the 2022-23 figure of £58.07.

Road Safety & Maintenance

Within The Forest, Surrey Wildlife Trust have coordinated a number of coppicing working parties to encourage regrowth of smaller trees. Two fallen trees on the lower path were also cleared. The planned surface improvements on two muddy sections of the upper path running parallel to the railway line are on schedule to be completed this spring.

As previously communicated, the Woodlands Trust has been overseeing ash dieback felling within sections of Great Ridings Wood. This has been necessary in order to protect public safety and it is hoped the woods will naturally regenerate over time.

PLANNING & ENVIRONMENT

HOW OUR COMMITTEE WORKS

EAST HORSLEY PARISH COUNCIL (EHPC) is a statutory consultee for all new planning applications in the village and submits views to the local planning authority, Guildford Borough Council (GBC), through a public consultation process.

Our Planning & Environment Committee comprises five parish councillors who meet publicly every fortnight to review the latest applications. During 2022 a total of 100 applications were assessed by this committee, which raised objections against 18, together with detailed justification – the most frequently-cited reasons being out of keeping with local character, harm to the local street scene and adverse impacts on residential amenity.

Whilst GBC are legally required to consult with us, their planning officers are not obliged to follow our advice.

The respective decisions made by EHPC and GBC on applications over the past five years are summarised in the table. It shows that GBC refused between 11% and 14% of annual

planning applications in East Horsley over the past five years. EHPC objected to between 16% and 29% of these applications; our congruence with GBC's decisions ranged from 78% to 89%.

Of the 18 objections we raised during 2022, only seven have yet been determined. Two of these were refused by GBC, one was approved after a design revision and one was withdrawn.

Three applications were approved despite our objections, most notably the Local Plan site for 110 homes at Lollesworth Fields near to Horsley Station.

Trends in East Horsley housing developments

DATA FROM our Planning Committee also helps illustrate the trends in new housing developments in East Horsley. The table below classifies all new applications in terms of extensions, knock-downs & rebuilds, infill developments and 'others' which covers gates, garages, outbuildings, etc.

Home extensions are the dominant feature of East Horsley residential development with an average of 62 extensions applied for each year, including revised applications. The data suggests that around one household in six has sought to enlarge their home over the past five years.

Knock-down and rebuilds have become more common in the village in recent years with an average of nine owners per year seeking to demolish their properties and rebuild them on the same plot, usually on a rather larger scale.

Work starts at Lollesworth Fields – now renamed Ada Gardens

Residential infilling is the main source of net new housing in the village with an average of seven infill developments per annum in East Horsley over the last five years.

The five-year village total is 204 net new homes, equivalent to an 11% growth in our village housing stock.

The list is dominated by the Local Plan site at Lollesworth Fields near Horsley Station where Taylor Wimpey have recently commenced construction of 110 homes under the marketing name of 'Ada Gardens'.

The next largest development is 10 flats in a new apartment block beside Thatcher's Hotel – this delayed planning application is expected to be determined by GBC very soon.

The Lollesworth Fields development includes 44 new Affordable Homes, mostly apartments. This represents an increase in the stock of affordable housing in East Horsley of some 45%.

STATION UPGRADES ON TRACK

The upgrades arriving at platforms one and two...

LIKE IT OR NOT, it's clear for all to see that sooner rather than later, our local rail stations (Effingham Junction and Horsley) are set to become the main public transport hubs for a lot of new users.

And it's good to report that the rail authorities are responding.

Following the recent resurfacing of the Horsley Station car park, four more projects are coming down the line from South Western Railway.

Waiting room makeover

First up, Horsley's London-bound platform waiting room is getting a major facelift in May.

There will be a new wood effect floor. Also, the unforgiving metal bench seats (below) are being replaced by more comfortable, single chairs.

In addition, a new "standing workstation" will be installed with charging points, the heater will be thermostatically controlled, rather than be on a timer, and the walls will get a fresh coat of paint.

The second project is the long overdue freshening up of the platforms with the paintwork getting a new coat in South Western Railway's corporate colours.

We are told this will include the original cast ironwork supporting the roofs.



Other upgrades

Big changes are also in the offing on the Guildford-bound platform. Here there is at last clear light at the end of the tunnel for a major upgrade for which EHPC's Railway Task Group has long been campaigning. Out will go the decrepit loos and in will come 21st century facilities. The waiting room will be enlarged and get the "standing workstations" and other improvements that are arriving sooner on the other platform. And fourth, but by no means least, something that has happened already: the "live entertainment" project. Yes, thanks to the ever resourceful Customer Ambassador, Richard Bunce, the waiting room on the London-bound platform now sports a glitzy piano!

So enjoy the improved waiting rooms and the gleaming new paintwork and "watch this space".


80 MPH on Forest Road!

Resident Andy Gibson reports on the results of a recent survey to assess the extent to which motorists exceed the 30 mph limit.

DURING THE FIRST WEEK of December last year vehicles on Forest Road were recorded travelling at over 80 mph on four occasions! If that headline isn't startling enough, over 2/3rds of vehicles were exceeding the 30 mph limit.

A survey was carried out by Surrey Safer Camera Partnership on behalf of Surrey County Council using latest radar technology for capturing traffic data located between Wildwood Close and Falconwood from 28 November to 6 December.

Average daily traffic flow was about 3500 vehicles of which 83.1% were cars, 15.6% light and medium goods vehicles and 1.3% HGVs. The graph below shows the number of vehicles grouped by the speed at which they were travelling. There were 155 instances of speeds



over 60 mph, 15 over 70 mph and 4 over 80. A total of 17,744 or 68.3% of all vehicles were recorded exceeding the speed limit.

This information is shocking and substantiates what residents already know and is why they have been asking to see this sort of data. Steve Rawlins, a Forest Road resident who has been campaigning for road safety measures for 20 years commented, "Our anecdotal comments regarding speeding are absolutely backed up here. Surely this provides ammunition for new traffic calming measures".

Parish Councillor, Antony Etwell, also a Forest Road resident on seeing the data said, "Quite frightening reading, especially because Forest Road has many school pick-up points. These figures must make us prioritise the installation of some form of traffic calming".

With such a high percentage of traffic speeding it is likely that this includes village residents as well as through traffic. Readers are asked to watch their speed and encourage others to do likewise.

Now this incontrovertible data exists, there is clearly a solid case to support immediate lobbying of Surrey Highways and the new Surrey Police team, tasked with reducing fatalities on the county's roads*, for traffic calming on Forest Road.

Community Speedwatch

YOU MAY WONDER why those chaps in hi-viz jackets pointing hairdryers at passing cars have nothing better to do – or you may worry instead that a fixed penalty or points notice will land on the doormat a few days later. In fact, they are representatives of Community Speedwatch and they are not out to "catch" anyone (which is why we don't hide behind bushes).

Speedwatch is really about education. Many drivers are unaware of the speed limit and in our well-insulated modern cars we often don't realise how fast we are travelling.

East Horsley Community Speedwatch is one of 83 volunteer groups across Surrey which



also include our colleagues in West Horsley. We typically log about 50 vehicles a month, including some travelling at 50mph in 30mph limit areas and 65mph where the limit is 40mph.

The aim is to curb speeding without recourse to fines or penalty points which cost police time and money and also don't make drivers happy. The worst that will happen in most cases is a polite letter from Surrey Police letting a driver know they were speeding.

We believe we are ourselves a traffic-calming measure, having noticed a reduction in speeding when we are out, particularly at village-centre sites. Statistics compiled by Surrey Police confirm the activity is worthwhile. Only around 5% of those logged are repeat offenders, even though many drivers who pass our volunteers are travelling the same routes every day.

Persecuted in Iran – now safe in East Horsley

Sohrab and Samira Farjoud are just two of the many refugees currently residing at Thatcher's Hotel whilst they wait for their asylum application to be reviewed. Steve Harvey hears their story.

SOHRAB FARJOUND was born and grew up in Iran where he worked for many years as a mechanic on Iranian-registered cargo ships. Originally a Muslim, he converted to Christianity when he met and married his wife Samira, a practising Christian. Sohrab explains that there are many people of Christian faith living in Iran, but all are required to keep a low profile for fear of persecution from the government.

After discussing their situation, Sohrab and Samira realised that they had no choice but to leave Iran and head for Europe, so they packed a few items in the dead of night, without telling friends or family, and headed by car for Germany, a perilously long drive with their two young children Samyar and Diyana. Yet even in Germany, the Iranian authorities were soon harassing them, suggesting they should return to Iran and they would be safe. However, as far as Sohrab was concerned, this would result in further persecution and even imprisonment, so the family took the decision to leave Germany and head to the UK.

Once here, they were transferred to Thatcher's Hotel and after settling in they began their search for a Protestant church where they could worship. Initially they thought both St Martin's and St Mary's were Catholic and they would not be welcome. However, once they realised their mistake, they embraced St Martin's and are now regular churchgoers. Samira lends a hand at the Thursday coffee mornings and Sohrab has been helping to restore the wooden arch that forms the entrance to the church. Samyar and Diyana attend schools in Effingham to continue their education. Sohrab is keen to get a paid job to support his family, but in the meantime has to wait for the Home Office to process his application for asylum. The family say they have been touched by the welcome from Horsley residents, especially churchgoers, and feel that the expense and hardship associated with their hazardous journey from Iran to Horsley has been well worth it.

PROTECT THE LOCAL ENVIRONMENT

What can we all do to help...

THE HORSLEYS and surrounding villages are facing some of the biggest changes ever due to the pressures from housing development. The last GBC Conservative administration's removal of villages from the Green Belt is damaging the landscape and destroying natural habitats all around us as new estates arise from the bulldozer's destruction.

Practical action by residents to challenge this increasing threat was the thrust of my speech when presented with the Parish Council Chairman's Award at the end of 2022 and which I have been asked to summarize here.

The award was mainly for 40 years fighting

damage and abuse to local woodlands. However, on a more positive note my campaign 30 years ago was to encourage residents to donate to the Woodland Trust sufficient funds to buy the 28 acres near Effingham Junction Station known as Clamp Rough and Gallows Grove. Without this generosity and foresight, we would probably have yet another housing estate suffocating the local infrastructure. Great Ridings Wood of 80 acres followed soon after and then The Forest in The Drift with Surrey Wildlife Trust.

We now have approximately 1500 houses arriving within 2-3 miles of East Horsley and about which we can do little. Michael Gove announced last year a change from Government-imposed housing numbers to allowing councils to decide, although this is yet to arrive in statute.

The biggest test case for this locally and the one which all of us can do something about is the massive and preposterous Wisley New Town totalling 2100 houses over 10+ years. Taylor Wimpey's application is now due sometime after May which is also the time of local Borough Council elections.

My message to all villagers is threefold: firstly to object to planningenquiries@guildford.gov.uk App 22/P/01175 and if you have objected then make another and also encourage others; secondly to join Villages Against Wisley New Town (VAWNT) who can help you object by emailing them on vawnt.group@gmail.com; lastly, make sure your vote counts for the local councillors offering the best environmental protection; it is the Borough's planning committee that will be deciding the fate of our local environment.
